The Lithuanian Council for Culture, in accordance with point 1 of paragraph 3 of Article 7 of the Law on the Council for Culture of the Republic of Lithuania, the provisions of the Statute of the Baltic Culture Fund, and points 32–36 and 46 of the Description of Procedures for the Administration of the Baltic Culture Fund for the period 2025–2027, approved by the Order of the Minister of Culture of the Republic of Lithuania No. IV-940 of 28 November 2024 and the minutes of the Meeting of the Expert Committee of 31<sup>st</sup> March 2025 No. 3LKT-14 (1.7), hereby decides:

3. The project coordinators referred to in Point 1 of the present Decision shall submit a duly completed and signed contract to the Lithuanian Council for Culture no later than 13th

May 2025, in the form prescribed by the Chairperson of the Lithuanian Council for Culture. If the project coordinator fails to submit the contract within the specified deadline, the grant to the project specified in Point 1 of the present Decision shall not be allocated.

4. The present Decision may be appealed against in accordance with the procedure established by the Law on Administrative Proceedings of the Republic of Lithuania, either to the Lithuanian Administrative Disputes Commission or directly to the Vilnius Chamber of the Regional Administrative Court, within one month from the date of receipt of the notification of the adopted decision.
